Subject: 2023-24 Capital Project Approval Update

Background

On March 26, 2024, the Board of Trustees approved the award of contracts related to the Capital Projects presented in the *2023-24 Capital Project Approval* report. This report provides an update to the Capital Projects presented in March, with updated information.

As described on March 26, 2024, the total funding from School Condition Improvement and School Renewal Capital allocations includes:

Appendix A presents the updated proposed capital project budget for renewal projects requiring Board approval in accordance with Sec. B Policy – Purchasing. Two projects have been added to the summary. Firstly, Sacred Heart, Sarnia – Additional Interior Renovations was added as a result of receiving the Ministry of Education approval to proceed. Secondly, the project scope of Ursuline College – Cafeteria Renovations was expanded after receiving input from school administration and the estimated cost now exceeds the threshold requiring Board approval.
