A. PRESENTATIONS

1. Special Education Budget 2024-2025

 A website highlighting all information for special education funding will be available upon request.

Marcie Myers

- The budget is balanced this year and it will be presented to the Board of Education for approval on June 18, 2024.
- A significant restructuring of education funding occurred in 6 funds this year, one of which was the Special Education fund.
- Marcie walked SEAC through the funding changes from the Ministry, as well as the proposed budget for Special Education for the 2024-2025 school year.
- An overview of the Differentiated Needs Allocation, Complex Supports Allocation and the Specialized Equipment Allocation funds was given.
- SEA funding underwent significant changes this year \$200,000 base amount and per pupil amount resulted in an increase to \$700,000.
- Expenses related to staffing, and supplies and services related to Special Education were reviewed.
- Staffing expenses include Bill 124 Planning Provisions to account for salary increases as a result of this legislation.
- Destreaming support funds were discontinued by the Ministry in the 2024-2025 school year, equivalent to 3.5 teachers.
- \$65,000 was provided by the Ministry to hire a Special Education System Navigator.
- The budget will be reassessed in the Fall, and there is a \$337,000 contingency fund to address needs.





2. Special Education Report

- Jen shared the changes to the Special Education Report that will be sent to the Ministry.
- Changes occurred in the following areas: Consultation Process, Early Identification Procedures and Intervention Strategies, Identification Placement Review Committee Process, Educational and Other Assessments, Placements Programs and Services, Provincial and Demonstration Schools, Staff Development, and Special Education Advisory Committee.

1. Accessibility Report

Lisa Demers

- The <u>report</u> includes the barriers that were addressed in the past year, and goals for the upcoming year.
- Types of barriers include attitudinal, architectural and physical, technological, and policy.
- Attitudinal barriers are addressed through professional development.
- Technological barriers are addressed through SEA equipment and training.





2. Lexia/Lexia Pilot

Jen Morrow

- In previous years, students in Grades 2-4 who were reading below the provincial standard had licenses, as well as students with SEA licenses.
- This model did not have a high level of program fidelity so licenses were not used effectively and consistently.
- This year, the literacy team chose five Grade 1 or Grade 1/2 classes to use the program, providing support to the classroom teachers as mentors and coaching the students how to effectively use the program.
- In this whole class program model, there was significant growth in the number of students reading at, and above reading level.
- Next year, all Grade 1 and 2 students and all Grade 3 French Immersion students will have licenses.
- Grade 1 and 2 French Immersion students will access a program called Lalilo, a similar tool to Lexia that supports French language learning.

3. Phonological Awareness Group Results

Katie Papanayotou

Phonological Awareness Groups:

- A total of 111 students received phonological awareness intervention.
- PRTs were given parameters for selecting students with low phonological awareness skills to be prescreened by SLPs.
- Small groups of students (five or less) received intervention from the Communicative Disorders Assistants (CDAs).
- The order of sessions followed a progression of phonological awareness skills ranging from identifying the number of syllables in a word to medial sound substitution.
- Sessions were planned based on the screening scores.
- Progression was evident as a result of the interventions.
